You must notify us within 90 days of the receipt of the merchandise if you intend to return the display and unsold product. We will not accept returns after 90 days. The customer is responsible for freight costs when returning the display and merchandise. Displays that are not returned will subject to a \$250.00 fee.

Customers choosing Option 1 or 2 can send a check in advance of the shipment or pay with a credit card. All other orders must be secured with a credit card. Customers who choose Option 3 will not have their credit card billed for the balance of the invoice until the end of the 90 day period. Customers who want to return their program must contact Shade Tree Greetings in advance of the expiration of their 90 day period for a Return Authorization number.
